


The balance of Tracy Reese Memorial Funds was used in October 2020 for equipment to stream worship services.

April 4th doesn't seem like that long ago but it was on that day we celebrated Easter together. We spoke a lot about resurrection and what that means for each of us individually and our community. It was on that date we celebrated Jesus overcoming an incredible challenge. So I wonder. Since that date approximately 56 days

ago, what challenges have you overcome? What challenges

have you met head on and trudged through? What challenges are you still trudging through?

Since that date approximately 56 days ago we have trudged through returning to in-person worship... lifting mask requirements to be present in our sanctuary... brought musicians back into our worship experiences... served Senior Citizen lunches... and held our last "second of the month" Covid focused Church Council meetings on Tuesday, May 25th.

The total amount of the PPP Income of \$15,810 has now been used for the 2021 payroll. Dan has contacted the SBA to start the process of applying for the Forgiveness, he is still waiting on an email from them so he can start the paperwork; we don't foresee anything having to be paid back.

It was agreed to turn on the TVs in the foyer during service so that those sitting in the foyer can view the service when there isn't enough seating or if a parent needs to take a child out of the sanctuary, the matter will be brought up to Greg and Jonathan.

Since Tina, Katey, and Jolie are no longer doing Bible School the council is reaching out to the congregation to see if anyone would like to take over. We will still proceed with ordering materials for VBS, if we do not use them this year we can save them for next year.

The council has approved the endowment request from Lisa Calvert and Ann Nicholson for \$4,000 on behalf of Habitat of Evansville for a Northern Posey County build.

A lock has been placed on the breaker box inside the garage. The rental price for our parking lot has been settled at \$150 for wedding reception parking on August 28th from noon to midnight. The gutters need replacing and there's cracks in the plaster ceiling in the parsonage, we have approximately \$2,300 left over in the parsonage remodel fund that we can use for the repair.

The council agrees to have a retreat sometime in early June.

Plans are moving forward on the playground renovation, BNS has provided us with a renovation layout of the new playground with prices, they will remove the old equipment and install the new pieces. The cost should be somewhere around \$50,000 to \$80,000 depending on the equipment chosen.

We will go back to regular communion but leave the offering plates at the door for now.


Should we start using bulletins again? We will hold off on bulletins.
